Means that, in exposures to this substance, the contribution by the cutaneous route, including the mucous membranes and eyes, may result significant for the overall body content if no measures are taken to prevent absorption. There are some chemicals for which dermal absorption, both in liquid and vapour phases, can be very high, and this route of entry may be or equal or greater importance even that inhalation pathway.
